

ADDITIONAL INFORMATION:

The Fairmont Park Neighborhood Association has recently notified staff that they have voted in favor of expanding the boundaries of their neighborhood. The boundary change would add the area formerly known as the Garton West Neighborhood to the Fairmont Park Neighborhood. Many residents in this area have been actively participating with the Fairmont Park Neighborhood since Garton West disbanded in 2008.

The new boundaries of Fairmont Park will include the area bordered on the west by Delaware Avenue, north by E. Euclid Avenue, south by Easton Boulevard, and east by E. 33^{rd} Street and Hubbell Avenue. A map of the proposed boundary change is included that shows the existing boundaries of the Fairmont Park Neighborhood and the former Garton West Neighborhood that would be added.

Staff agrees with the expansion of the Fairmont Park Neighborhood boundaries to include the former Garton West Neighborhood. This change will allow the residents of the former Garton West Neighborhood to participate with the Fairmont Park Neighborhood and receive the benefits of being part of a Recognized Neighborhood Association.
