# **AGENDA HEADING:**

Authorize notice of public hearing for April 7, 2014 on the Fourth Amendment to the Guthrie Avenue Business Park Urban Renewal Plan.

### SYNOPSIS:

This Fourth Amendment to the Guthrie Avenue Business Park Urban Renewal Plan will provide an update of proposed projects within the plan area, an update of the Financial Condition report and provide for a review of the plan's design standards with current City landscaping and design standards. The amendment also extends the urban renewal plan and tax increment finance (TIF) designations to June 30, 2029 to provide additional time for property acquisition and redevelopment. The current plan and TIF designation are scheduled to terminate on September 30, 2019.

This authorization also directs that future actions be undertaken including the required tax increment consultation meeting, publication of the public hearing notice and referral to the Urban Design Review Board to review the proposed plan amendment and make its recommendation to the City Council.

# FISCAL IMPACT:

<u>Amount</u>: Purchase prices are to be determined and will be set by the market. The Plan enables annual cash available from the tax increment revenue to be used to acquire the remaining acres of land in the park boundary and prepare the land for redevelopment.

Funding Source: Guthrie Avenue Business Park tax increment revenue.

# **ADDITIONAL INFORMATION:**

In 1988, the Guthrie Avenue Urban Renewal Plan was created to enable small to medium scale light industrial businesses to locate in an area served by rail, directly west of I-235 and near the junction of Interstates 35 and 80. The area was previously characterized by numerous salvage yards and significant amounts of blighted and vacant space.

Redevelopment activity has been directed to providing reasonably priced sites for sale to small and mid-sized businesses. With the area's proximity to the interstate system and M-1 zoning, it has strong appeal to businesses that could have otherwise located outside of Des Moines.

The Guthrie Avenue urban renewal project has provided public funds, through tax increment financing as well as other federally funded grants, to provide needed infrastructure and purchase property for

redevelopment in order to leverage new private redevelopment investment. Significant new redevelopment in the park includes Moss Distribution, ABC Supply, Library Binding Services (LBS), Midwest Automatic Fire Sprinkler, Central Wire and Iron and Doll Distributing LLC. These new businesses have increased the area's property assessments from about \$3 million in 1988 to an estimated \$40 million today with about 710 jobs created or retained.

The urban renewal plan provides for acquisition of the remaining properties in plan area boundary, due to their blighted condition or uses which are not appropriate in this M-zoned area. As of today, about 2/3 of the properties in the urban renewal area boundary have been purchased by the City and sold for private redevelopment; approximately 21 acres remain to be purchased and sold for redevelopment.
