#### **AGENDA HEADING:**

Ordering construction of the following: Beaver Avenue Streetscape - Beaver Crest Drive to Fagen Drive - receiving bids, (3-18-14), and setting date of hearing, (4-7-14). Construction Estimate - \$1,563,732.

### **SYNOPSIS:**

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the construction of streetscape enhancements on Beaver Avenue from Beaver Crest Drive to Fagen Drive and on Urbandale Avenue east and west of Beaver Avenue. The intersection of Beaver Avenue and Urbandale Avenue will be enhanced to improve vehicular and pedestrian safety and new traffic signals will be installed. The project also includes the construction of storm sewer along Beaver Avenue to separate existing combined sewers and improve the overall drainage in the area.

## **FISCAL IMPACT:**

Amount: \$1,563,732 City Engineer's Estimate

<u>Funding Source</u>: Recommended 2014-2015 Capital Improvement Program (CIP), Page Street - 5, Beaver Avenue Streetscape, ST245, Being: \$439,000 (maximum) in Federal Surface Transportation Program (STP) funds being 80% eligible construction costs under IDOT Project No STP-E-1945(804)-8V-77; \$350,000 Storm Water Utility Funds, SM057; \$300,000 from Beaverdale Betterment Coalition; \$46,000 from Des Moines Water Works for water main construction; and the remaining \$428,732 in G.O. Bonds, ST245.

## **ADDITIONAL INFORMATION:**

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Beaver Avenue Streetscape - Beaver Crest Drive to Fagen Drive, 04-2012-005. The improvement includes construction of sidewalks, driveways, site furnishings, plantings, miscellaneous Portland Cement Concrete, and an HMA Pavement Overlay, together with the necessary removals, earthwork, clearing and grubbing, erosion control, subdrains, storm sewers, traffic control, traffic signals, and street lighting; all in accordance with the contract documents, including Plan File Nos. 556-102/211, on Beaver Avenue from Beaver Crest Drive to Fagen Drive, Des Moines, Iowa.

The estimated construction cost is \$1,563,732. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
