AGENDA HEADING:

Hold hearing for conveyance of a portion of the vacated east/west alley right-of-way adjoining 1709 Francis Avenue to Olga Marina Ayala for \$25.

SYNOPSIS:

Recommend approval for conveyance of a portion of the vacated east/west alley right-of-way adjoining 1709 Francis Avenue to Olga Marina Ayala, 1709 Francis Avenue, Des Moines, Iowa, 50314, for \$25. This action is required by Iowa law prior to making a final determination on the proposed sale by resolution. The sale of this portion of excess property will allow the buyer to assemble the alley right-of-way with her existing residential lot. There is no current or anticipated public need for this property, and this conveyance will eliminate future maintenance and liability costs for the City and will return the property to the tax rolls.

FISCAL IMPACT:

Amount: \$25 (Revenue)

Funding Source: Non-project related land sale proceeds are used to support general operating budget expenses: Org – EG064090

ADDITIONAL INFORMATION:

On February 6, 1978, by Roll Call No. 78-0526, City Council approved and adopted Ordinance No. 9365 vacating all of the east/west alley right-of-way north of Francis Avenue and south of Hickman Road between 18th Street and 16th Street, including the portion thereof adjoining 1709 Francis Avenue.

Olga Marina Ayala owns 1709 Francis Avenue adjoining said alley right-of-way, and has offered to the City of Des Moines the purchase price of \$25 for the purchase of the vacated alley right-of-way. The property to be conveyed consists of approximately 400 square feet and the purchase price reflects the fair market value of the property as currently estimated by the City’s Real Estate Division.
