Resolution closing public hearing on proposed sale of City-owned property at 505 East Grand Avenue to 505 East Grand, LLC for \$369,600.

SYNOPSIS:

Recommend approval of the sale of the City-owned surface parking lot located at the southeast corner of East Grand Avenue and East Fifth Street to 505 East Grand, LLC (Jake Christensen, 506 3rd Street, Des Moines, Iowa) for a new 18,000-square-foot building for retail and commercial space.

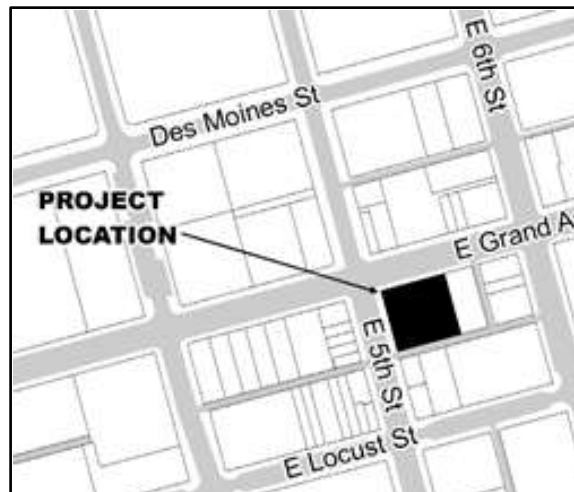
FISCAL IMPACT:

Amount: \$369,600 (Revenue)

ADDITIONAL INFORMATION:

The City has owned the surface parking lot located on the southeast corner of East 5th Street and East Grand Avenue since the late 1960s. This property is currently used for leased and metered parking on this approximately 18,500-square-foot site. The proposed sale price of \$369,600 is based on comparable property sales in the East Village. The City’s Real Estate Division considers the sale price to be within a reasonable and acceptable range of the fair market value of the property.



The developer approached the Council in November 2013 and requested the sale of the property for development. The Council directed staff to work with him on preparing a development proposal. As has been related in various news articles, his proposed major first floor tenant, Raygun (400 East Locust Street), is under a tight timeline to relocate due to the sale of his current leased retail space. It is anticipated site work will begin in early May 2014.

The Historic East Village Association has, by letter, indicated its support of the proposed project and supports the City's upcoming parking study of the area.
