AGENDA HEADING:

Purchase of CrafcO Pavement Crack Sealant (Roadsaver 221) and Detackifier (detack), to be used in crack sealing operations, during fiscal year (FY) 2015.

SYNOPSIS:

Recommend approval for City’s Purchasing Agent to issue a blanket purchase order for CrafcO Pavement Crack Sealant and Detackifier to Logan Contractors Supply (4101 106th Street, Urbandale, Iowa 50322, Bruce Logan President), the sole area-wide distributor.

FISCAL IMPACT:

Amount: \$65,000

Funding Source: FY 2014-2015, C038EN99/ ST217, Capital Projects/Special City-wide Street Improvements, page Street Improvements—34

ADDITIONAL INFORMATION:

The Department of Public Works utilizes a CrafcO SS125 Sealant Melter/Applicator extensively in its pavement maintenance program to seal cracks that develop in the pavement, thereby extending the pavement life. CrafcO sealant is required to use in the CrafcO Melter/Applicator. Municipal Code section 2-726(a)(7) provides for a non-competitive procurement of materials when the required materials are available only from a single area-wide distributor and competitive bids for such materials are not reasonably attainable. The cost for the sealant and detack price remained the same, \$.61 per pound and \$30 per pail respectively.
