AGENDA HEADING:

Approving Supplemental Agreement No. 1 to the Professional Services Agreement with Foth Infrastructure and Environment, LLC for additional environmental, final design, and construction administration services for E. Payton Avenue Bridge Replacement over Stream, not to exceed \$38,627.

SYNOPSIS:

Recommend approval of Supplemental Agreement No. 1 to the Professional Services Agreement with Foth Infrastructure and Environment, LLC (Patrick Kueter, Principal-in-Charge, 8191 Birchwood Court, Suite L, Johnston, Iowa 50131) not to exceed \$38,627, for additional environmental, final design, and construction administration services for E. Payton Avenue Bridge Replacement over Stream.



ADDITIONAL INFORMATION:

On April 22, 2013, by Roll Call No. 13-0628, City Council approved a professional services agreement with Foth Infrastructure and Environment, LLC for evaluation, design, and construction phase services for E. Payton Avenue Bridge Replacement over Stream. During the design process, existing wetlands were encountered that would be disturbed by the proposed construction activities. Wetland mitigation strategies need to be evaluated and proposed to the U.S. Army Corps of Engineers (USACOE) for approval, which may include constructing on-site wetland mitigation areas or wetland mitigation banking, or a combination thereof. Supplemental Agreement No. 1 reflects the additional costs to evaluate and develop wetland mitigation strategies for agency approval, perform construction administration services during any on-site wetland mitigation construction, and complete any required wetland monitoring as a condition of the USACOE permit.
