AGENDA HEADING:

Approving Supplemental Agreement No. 2 to the 2011 System Wide Local Flood Protection Project Improvements professional services agreement with Howard R Green Company for design and construction phase services, not to exceed \$102,500.

SYNOPSIS:

Recommend approval of Supplemental Agreement No. 2 with Howard R. Green Company (Don Lovett, Chief Operating Officer, 5525 Merle Hay Road, Suite 20, Johnston, Iowa) for a total cost not to exceed \$102,500, based on hourly rates, to provide additional design and construction phase services for the 2011 System Wide Local Flood Protection Project Improvements project.

ADDITIONAL INFORMATION:

On June 27th, 2011, by Roll Call No. 11-1073, the City entered into a professional services agreement with Howard R Green Company for design and construction services related to various improvements needed on the levee system. The original agreement included design services for a levee relief well project to be constructed along the DM-II levee. A preliminary design was developed and reviewed by the Corps of Engineers. In order to meet Corps requirements, it was determined that additional testing of the test wells as well as a revised conceptual design based on those test results will be required. Supplemental Agreement 2 includes the additional testing and design services to address Corps of Engineers requirements.
