AGENDA HEADING:

Approving Supplemental Agreement No. 2 to the professional services agreement with Brown Engineering Company for Des Moines Skywalk Bridge Roof Analysis & Design, not to exceed \$31,400.

SYNOPSIS:

Approve Supplemental Agreement No. 2 to the Professional Services Agreement between the City of Des Moines and Brown Engineering Company (Brian Elliott, President, 5525 Meredith Drive, Suite D, Des Moines, IA 50310) for a total cost not to exceed \$31,400, based on a lump sum amount; to provide additional design and construction phase services for Des Moines Skywalk Bridge Roof Analysis & Design.

FISCAL IMPACT:

Amount: \$31,400

<u>Funding Source</u>: 2014-2015 Capital Improvement Program (CIP), Page Streets – 29, Skywalk System, SW094, Tax Increment Financing (TIF) Bonds

ADDITIONAL INFORMATION:

On June 24, 2013, by Roll Call No. 13-0971, City Council approved a professional services agreement with Brown Engineering Company to inspect and analyze the condition of each City-owned Skywalk Bridge Roof and provide design, and construction phase services for any Skywalk roof in need of immediate replacement. From this analysis, it was determined that six (6) Skywalk roofs were in need of immediate replacement. These replacements are nearly complete, with one (1) roof remaining to be replaced, and one (1) indefinitely postponed due to the Younkers fire.

From the analysis it was determined that eight (8) additional Skywalk roofs were in need of replacement in 2014. Supplemental Agreement No. 2 reflects the additional cost to provide the design and construction phase services for these eight (8) Skywalk roofs.
