AGENDA HEADING:

Designation of lowest, responsive, responsible bidder as Iowa State Contractors, Inc., Joseph Cichowski, President; approval of contract and bond on S.W. 14th Quiet Street, \$149,995.

SYNOPSIS:

Designate the lowest, responsive, responsible bidder on the S.W. 14th Quiet Street and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project will develop a portion of Druid Hill Drive, Casady Drive, S.W. 14th Street, West Street, S.W. 10th Street, and Rittenhouse Street into a quiet street to slow vehicle traffic while facilitating safe and convenient bicycle travel. This will be accomplished by constructing medians, a raised crosswalk at Wright Elementary school, speed feedback signs, and pavement markings. A raised median with a pedestrian refuge will also be constructed at the Blank Park Zoo entrance on S.W. 9th Street at Rittenhouse Street.

FISCAL IMPACT:

<u>Amount</u>: \$149,995 Construction Contract (\$169,000 City Engineer's Estimate)

<u>Funding Source</u>: 2014-2015 Capital Improvement Program (CIP), Page Park – 9, Multi-Use Trails, PK045, Being: \$112,496.25 in Iowa Department of Transportation (IDOT) State Recreational Trails funding (75% max) eligible construction costs, which is the eligible remaining amount of the \$439,920 per Agreement 2012-RT-007; with the remaining \$37,498.75 in G.O. Bonds.

ADDITIONAL INFORMATION:

The Southwest 14th Quiet Street project has been through an extensive public input process. On June 13, 2011, by Roll Call No. 11-1046, the City Council adopted the Bicycle and Trail Master Plan as an element of the 2020 Community Character Plan. The Bicycle and Trail Master Plan, which also went through an extensive public input process, identified the quiet street as one of three (3) priority projects that could make a major positive impact on the ability to safely bicycle in the City.

On June 18 and 19, 2012, the City hosted public open houses to begin the design process for the S.W. 14th Quiet Street project. The first open house described the parameters of the project and presented the purpose and tools for creating a quiet street. Approximately 80 attendees, the majority of whom live in the affected Watrous South and Gray's Lake Neighborhoods, attended this first meeting and had the opportunity to discuss questions and issues one-on-one with staff and consultants.


After gaining residents' input, the consultants, Alta Planning + Design, prepared several options for trafficcalming elements along the corridor and presented them at the second open house held the following day. The approximate 40 residents who attended this second meeting gathered into small groups around corridor maps, discussed the proposed options, and provided feedback.

In the months following the open houses, Park and Recreation Department staff worked with small groups from both of the neighborhood associations and other City departments to finalize the elements. After the conceptual plan was developed, it went through the following steps of public review:

- On September 10, 2013, the concept was presented to the Traffic Safety Committee for informational purposes, with no action to be taken.
- On November 25, 2013, City staff held a public meeting to present the conceptual plan to a group of approximately 60 residents of the neighborhoods and interested parties.
- On December 9, 2013, the Des Moines and Polk County Trails and Greenways Advisory Committee reviewed the conceptual plan and unanimously recommended approval.
- On December 16, 2013, the Park and Recreation Board reviewed the conceptual plan and a majority (12-2) voted to recommend to City Council that it approve the plan.
- On January 27, 2014, the City Council reviewed and approved the conceptual plan.

On May 19, 2014, by Roll Call No. 14-0814, there was a public hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement, and the public hearing was closed. The City Council approved said plans, specifications, form of contract documents, and City Engineer's estimate, and received and filed bids, for the construction of the S.W. 14th Quiet Street, 06-2014-001. The improvement includes construction of medians, pavement widening, HMA raised crosswalk, sidewalks, speed feedback signs, pavement markings, and other incidental items; in accordance with the contract documents, including Plans File Nos. 557-148/189, along S.W. 14th Street from Casady Drive to West Street and on S.W. 9th Street at Rittenhouse Street, Des Moines, Iowa.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Iowa State Contractors, Inc., Joseph Cichowski, President, 26 Greenbriar Lane, Ottumwa, IA 52501 in the amount of \$149,995, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
