AGENDA HEADING:

Amending Chapter 114 of the Municipal Code Regarding Traffic Regulation Changes as follows:

- A. Designating Ankeny Avenue as a “through” street.
- B. Designating Stanton Avenue as a “through” street between Fleur Drive and McKinley Avenue.
- C. Removal of handicapped parking meter on the south side of Mulberry Street between 5th Avenue and 6th Avenue.
- D. Removal of handicapped parking space from the west side of 16th Street south of Gillette Street.
- E. Loading Zone on the west side of E. 5th Street north of E. Grand Avenue.
- F. Downtown On-Street Bike Facilities Implementation.

SYNOPSIS:

Recommend approval of the staff recommendations, including first reading of the ordinance regarding the traffic regulation changes.

FISCAL IMPACT:

Amount: Minor costs for signing modifications.

Funding Source: 2014-2015 Operating Budget, Page 74, Engineering Department Traffic & Transportation – Sign Installation and Maintenance, EG062080

ADDITIONAL INFORMATION:

- A. This ordinance revision would define Ankeny Avenue as the “through” street and allow the installation of a STOP sign at the intersection of Ankeny Avenue and E. 20th Court. The following revisions to the Municipal Code will place this designation into effect.

Sec. 114-2136.5 Ankeny Avenue.

Ankeny Avenue, from the east line of Hubbell Avenue to the east line of East Twentieth Court, stop.

- B. In a field review of Stanton Avenue between Fleur Drive and McKinley Avenue, staff determined that several of the residential “T” intersections do not have stop signs along the side streets. In order to more clearly define Stanton Avenue as a residential collector street, it should be designated as a “through street” in the City code, which will allow staff to install stop signs on these residential side street approaches.

This would not affect the existing four-way stop at the intersection of SW 26th Street and Stanton Avenue, or the existing two-way stop at SW 31st Street and Stanton, where Stanton Avenue traffic stops for 31st Street. At their May 13, 2014 meeting, the Traffic Safety Committee concurred with staff recommendation that Stanton Avenue be designated as a “through” street (stop) between Fleur Drive and McKinley Avenue. The following revisions to the Municipal Code will place this designation into effect.

Sec. 114-2338.5 Stanton Avenue.

Stanton Avenue, from the west line of Fleur Drive to the east line of Southwest Twenty-Sixth Street, stop.

Stanton Avenue, from the west line of Southwest Twenty-Sixth Street to the east line of Southwest Thirty-First Street, stop.

Stanton Avenue, from the west line of Southwest Thirty-first Street to the east line of McKinley Avenue, stop.

- C. The Polk County Courthouse has moved their accessible entrance to the west side of the courthouse. This is the last meter that had been left in place from the previous handicapped meter parking area before the courthouse access was restricted. During the month of January and first two (2) weeks of February 2014, staff surveyed the usage of this parking meter and determined that it was not being used at all. Staff did notice that the non-handicapped meters on both sides of the handicapped meter were being used. Since this location is no longer the closest accessible entrance to the courthouse, the handicapped parking designation on this meter should be removed. The following revision to the Municipal Code will remove the handicapped designation.

Sec. 114-3927. Mulberry Street—Fifth Avenue to Sixth Avenue.

~~Mulberry Street, on the south side, parking meter M 506, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.~~

- D. The office has been notified by the heir of the property located at 1312 – 16th Street that because of a recent death in the family, the handicapped parking space at this location is no longer needed. The following revision to the Municipal Code will remove the handicapped parking restriction in this area.

Sec. 114-2768. Sixteenth Street—High Street to Shawnee Avenue.

~~Sixteenth Street, on the west side, 105 feet south of Gillette Street to 25 feet south thereof, is designated a handicapped parking space, and is subject to the same prohibition as is found in subsection 114-616(a) of this code.~~

- E. At the request of American Marking, 440 E. Grand Avenue, Traffic and Transportation met with their representative to discuss a unique loading and unloading situation on the east side of their business. At one time the American Marking building had a drive-in overhead door located approximately 100 feet north of East Grand Avenue. This overhead door was accessed from East 5th Street by a driveway. At least 10 years ago, this overhead door was replaced with a storefront with just an access door. Loading of a considerable amount of materials for different jobs moves through this access door, and American Marking will park a truck in this area on the drive approach, backed up to the access door, while loading and unloading through this door. Recently, American Marking received a citation for illegal parking while loading their vehicle in this area. This area is an off-street loading area that serves no other business. The difference being that the area is oriented 90 degrees away from the curb line. Past practice has been to install parking meters or other traffic control signs through inactive curb cuts, when there is no longer an overhead door requiring the need of a curb cut. In this instance, because the area is being actively used as a loading zone, the recommendation would be to sign this 30-foot-wide area as a loading zone and allow the current loading and unloading to continue. Informally, we would also discuss the needs of the business with parking enforcement and ask that it be enforced in the same manner as a loading zone regardless of whether the vehicle is parallel to the curb (on-street) or oriented 90 degrees to the street direction and pulled up to the business to load and unload in the drive approach. The following revisions to the Municipal Code to place these changes into effect.

Sec. 114-4083. East Fifth Street--East Grand Avenue to Des Moines Street.

East Fifth Street, on the west side, from a point 45 feet north of East Grand Avenue to a point 400 55 feet south of Des Moines Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

East Fifth Street, on the west side, from a point 130 feet north of East Grand Avenue to a point 100 feet south of Des Moines Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-2635. East Fifth Street--East Walnut Street to Lyon Street.

East Fifth Street, on the west side, from East Grand Avenue to a point 45 feet north thereof, no parking anytime.

East Fifth Street, on the west side, from a point 100 feet north of East Grand Avenue to a point 30 feet north thereof, loading zone.

- F. Downtown on-Street Bike Facilities Implementation

In conjunction with the Downtown Bicycle Implementation Plan—Phase 1 project, which was completed in the fall of 2013, staff has reviewed the parking restrictions on the streets where bicycle lanes were installed. The following code changes are needed as part of the bike lane implementation.

Sec. 114-3258. Grand Avenue--Fifteenth Street to Seventeenth Street.

~~Grand Avenue, on the south side, from a point 370 feet west of Fifteenth Street to a point 25 feet east of Seventeenth Street, no parking 4:00 p.m. to 6:00 p.m.~~

Grand Avenue, on the south side, from Sixteenth Street to a point 25 feet east of Seventeenth Street, school loading and unloading, 30-minute limit, Monday through Friday, from 7:00 a.m. to 9:00 a.m. and 1:00 p.m. to 4:00 p.m. A thirty-minute limit, for all school passenger loading and unloading. A school-issued identification placard is required to identify authorized vehicles dropping off and picking up during the restricted hours, on school days. On the days and during the hours noted, the school placard serves as a City of Des Moines authorized on-street parking permit, at this location; no parking meter fee required when school placard is displayed as noted above.

Grand Avenue, on the north side, from a point 35 feet west of Sixteenth Street to a point 35 feet east thereof, no parking any time.

Sec. 114-3256. Grand Avenue--Thirteenth Street to Fifteenth Street.

Grand Avenue, on the north side, from a point 235 feet east of Fourteenth Street to a point 45 feet east thereof, no parking any time.

Grand Avenue, on the north side, from a point 346 feet east of Fourteenth Street to a point 75 feet east thereof, no parking any time.
