AGENDA HEADING:

Designation of lowest, responsive, responsible bidder as Iowa State Contractors, Inc. (Joseph Cichowski, President); approval of contract and bond on 2014 Americans with Disabilities Act (ADA) Modifications, \$136,008.

SYNOPSIS:

Designate the lowest, responsive, responsible bidder on the 2014 ADA Modifications and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project includes modifications to parking lots, access routes, pedestrian ramps, and ramp handrails at various locations to bring them into compliance with the requirements of the ADA.

FISCAL IMPACT:

Amount: \$136,008 Construction Contract (\$152,000 City Engineer's Estimate)

<u>Funding Source</u>: 2014-2015 Capital Improvement Program (CIP), Page Building - 4, ADA Modifications for Municipal Buildings, BL042, G.O. Bonds

ADDITIONAL INFORMATION:

On May 19, 2014, by Roll Call No. 14-0813, there was a public hearing on the plans, specifications, form of contract documents, and engineer's estimate of construction cost for said improvement, and the public hearing was closed. The City Council approved said plans, specifications, form of contract documents, and City Engineer's estimate, and received and filed bids for the construction of the 2014 ADA Modifications, 11-2014-005. The improvement includes modifications to sidewalks, parking lots, pavement markings, parking signage, pedestrian ramps, handrails, and other incidental items; in accordance with the contract documents, including Plan File Nos. 558-018/057, at the following locations: Blank Park Zoo - 7401 S.W. 9th Street, Des Moines Central Library - 1000 Grand Avenue, and Principal Park - 1 Line Drive, Des Moines, Iowa.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Iowa State Contractors, Inc. (Joseph Cichowski, President, 26 Greenbriar Lane, Ottumwa, IA, 52501) in the amount of \$136,008, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
