Westgate Partnership, LLC renovated the 29,068-square-feet, two-story building located at 1408 Locust Street. The Developer completed the project by the required date of March 31, 2012 in substantial compliance with the approved Conceptual Development Plan and is required to request the City issue a Certificate of Completion as evidence of satisfaction of the Developer's construction obligations under the Development Agreement, but such request was not received until recently.
