ADDITIONAL INFORMATION:

The following is an analysis of the funding estimates used to plan for the 2014 Program Year. Additionally, there is a breakdown of CDBG funds available for reprogramming and which programs will carryover funding to the 2014 Program Year. The funds available come from unspent 2013 CDBG funds.

Furthermore, staff recommends the carryover of \$163,147.55 of unspent CDBG funding for demolition from 2013 to the 2014 program year.
