## **ADDITIONAL INFORMATION:**

Terry Bennigsdorf, (NR-0) Senior Electrical Inspector, to Cleveland, OH, from September 20 – September 24, 2014 (\$1,251) to attend the 2014 annual Western Code seminar sponsored by the International Association of Electrical Inspectors. The seminar will provide the opportunity to learn the latest techniques for installing and inspecting the new green systems (solar and wind generation) that are coming on line, and reviewing changes in the upcoming 2014 National Electrical code. The meeting will also provide networking opportunities with inspectors in cities both locally and nationwide.

**T.M. Franklin Cownie**, (**R-1**) **Mayor**, to Sacramento, CA, from September 26 – September 30, 2014 (\$1,608.40) to attend the United States Conference of Mayors 2014 Fall Leadership meeting. The meeting provides the opportunity to connect with fellow mayors elected officials, and business leaders while learning about best practices from other communities.

**T.M. Franklin Cownie, (R-1) Mayor,** to Yichang, China and Kaohsiung, Taiwan, from September 9 – September 18, 2014 (\$0) to participate as a presenter at the 2014 International Conference on Disaster Mitigation and Adaption. The conference will promote building relationships with global

leaders in order to perpetuate goodwill and advance economic opportunities while taking advantage of international partnership and funding opportunities. The International Council for Local Environmental Initiatives has agreed to fund this trip.

**Laura Graham, (R-0) Assistant to the City Manager,** to Charlotte, NC, from September 14 – September 17, 2014 (\$2,226.34) to attend the International City Manager Association's annual conference. The conference provides access to an abundance of educational, information-sharing, and networking tools to help manage local government.

**Patrick Phelan, (R-0) Fire Protection Engineer,** to Long Beach, CA, from October 11 – October 17, 2014 (\$3,115) to attend the Society of Fire Protection Engineers 2014 SFPE Conference & Expo. Conference presentations are associated training seminars on various topics in the industry, providing the opportunity for professional development, training, and networking with representatives from across the fire protection industry.
