ADDITIONAL INFORMATION:

Bids were solicited for emergency snow and ice control equipment and dump bodies to be mounted on six (6) replacement tandem axle truck chassis. Two bids were received from Henderson Truck Equipment. One bid contained an additional option of non-compliant valve material. Fleet staff contacted other possible bidders to determine the lack of bid responses. One previous bidder has since gone out of business, another out of state manufacturer did not bid directly as in past bid solicitations. Another potential bidder indicated that due to a lack of industry availability of components to supply all requested equipment they did not respond.

Henderson Truck Equipment did provide two bids; however, the low bid with Certified Power Technology Incorporated brand hydraulic valve components was non-compliant with the requirement to provide an all-aluminum valve. An option contained in the second bid from Henderson Truck Equipment that provided Force America brand hydraulics was also non-compliant in the requirement of an all-aluminum valve. The compliant bid from Henderson Truck Equipment providing Force America all aluminum valve components is compliant with the specifications and therefore award is recommended to Henderson Truck Equipment.
