AGENDA HEADING:

Resolution approving operational agreement with Childtime Childcare, Inc. to operate and manage a childcare center in the Intermodal Transportation Facility at 6th Avenue and Center Street.

SYNOPSIS:

Recommend approval of the operational agreement with Childtime Childcare, Inc., Frank Jerneycic, Chief Financial Officer, 21333 Haggerty Road, Suite 300, Novi, Michigan, 48375, to continue to serve as operator of the childcare center in the Intermodal Transportation Facility at 6th Avenue and Center Street. The proposed operational agreement is in the best interests of the City and in accord with federal requirements associated with the Intermodal Transportation Facility. The agreement is for a three-year term at \$2,990 per month, with annual rent increases thereafter being equal to the Consumer Price Index (CPI), not to exceed 5%.

FISCAL IMPACT:

Amount: \$35,880 (first year revenue with annual CPI adjustments)


ADDITIONAL INFORMATION:

On April 28, 1997, by Roll Call No. 97-1549, the City Council entered into a 28E Agreement with the Des Moines Metropolitan Transit Authority (now Des Moines Area Regional Transit Authority) for construction and operation of a Park & Ride Facility. This facility included designs for a childcare facility to serve the needs of those families working in the downtown area.

Childtime Childcare, Inc. was selected as the childcare provider for this facility. On December 21, 1998, by Roll Call No. 98-3949, the City Council approved a four-year operational agreement with an additional two-year renewable option with Childtime Childcare, Inc.

On January 7, 2008, by Roll Call No. 08-0076, the City Council approved an operational agreement with Childtime Childcare, Inc. to operate and manage the childcare facility until March 31, 2009 with an option to renew the agreement for an additional five (5) years until March 31, 2014, which option to renew was exercised.

The City's Real Estate Division has negotiated the terms of a new operational agreement with Childtime Childcare, Inc. that includes, among other terms, a three-year term with an initial first year monthly rent of \$2,990. The second year monthly rent will be \$2,990 plus the percent increase in the CPI for the previous 12 months, not to exceed 5%. The third year monthly rent will be \$2,990 plus the percent increase in the CPI for the previous 24 months, not to exceed 5%. The terms of the operational agreement are based on an independent appraisal and have been approved by the Des Moines Area Regional Transit Authority and the Federal Transit Administration.
