#### **AGENDA HEADING:**

Approval of grant agreements with the U.S. Department of Housing and Urban Development (HUD) for funding of the City's Fifth Year (2014) Action Plan of the 2010-2014 HUD Consolidated Plan.

#### **SYNOPSIS:**

Recommend Council approval of grant agreements by and between HUD and the City of Des Moines, whereby the City will receive Community Development Block Grant (CDBG), HOME Investment Partnership program (HOME), and Emergency Solutions Grant (ESG) funding (grant awards) for the implementation of the Fifth Year (period of January 1, 2014 to December 31, 2014) Action Plan of the 2010-2014 HUD Consolidated Plan.

#### **FISCAL IMPACT:**

Amount: \$4,511,028

<u>Funding Source</u>: FY 2014-2015 Operating Budget, Community Development: Special Revenue Funds, S020 CDB09914, Community Development Block Grant Fund, Page 51; SO36 HOM02014, HOME Fund, Page 52; S039 HES09913, Homeless Fund, Page 53.

### **ADDITIONAL INFORMATION:**

At the City Council meeting on September 23, 2013, the Council approved the Fifth (2014) Year Action Plan of the 2010-2014 HUD Consolidated Plan consisting of CDBG, HOME, and ESG funding. From 2013 to 2014, funding for CDBG has decreased by \$62,470; funding for HOME has increased by \$839; and funding for ESG increased by \$42,260. The Grant Agreements must be processed in order to receive HUD drawdowns.
