AGENDA HEADING:

Approving the Viva East Bank! Coalition Memorandum of Understanding.

SYNOPSIS:

Approving the City of Des Moines to sign Memorandums of Understanding to participate in Viva East Bank!, a coalition of partner organizations and residents working together to implement the Neighborhood Revitalization Plans for Capitol Park, Capitol East, and Martin Luther King Jr. Park.

ADDITIONAL INFORMATION:

In 2011, the City selected Martin Luther King Jr. Park to participate in the Neighborhood Revitalization Program as a designated neighborhood. At the same time, Capitol East and Capitol Park were selected to go through a special pilot process to update their neighborhood plans, in partnership with the City and Iowa State University. All three (3) neighborhood plans were completed and adopted by the City in 2014.

Throughout the planning process, potential implementation partners, including neighborhood stakeholders such as schools and businesses, as well as community non-profit organizations and other units of government, helped develop strategies and action steps to achieve plan goals. Many of these organizations continue to have interest in implementing the neighborhood plans. Because the priorities expressed by the three (3) neighborhoods are very similar, and because the neighborhoods are geographically adjacent to one another, there are many opportunities for collaboration. The three (3) neighborhoods and many partner organizations have decided to come together under a single revitalization initiative, entitled Viva East Bank!, to implement the plans in a coordinated way.

Taking lessons from the successful Thrivent Builds Neighborhoods program implemented in King Irving and Mondamin Presidential from 2008-2011, the City and other organizing entities (Greater Des Moines Habitat for Humanity, Community Housing Initiatives, Child and Family Policy Center) created a similar organizational structure for the Viva East Bank! Coalition. A Steering Committee made up of representatives from the organizing entities, Neighborhood Associations, the Des Moines Public School District (pending), United Way (pending), and major funders, will provide oversight, guidance, and accountability. Partner organizations and neighborhood residents will come together via work groups on specific topics to move projects forward. Currently, Viva East Bank! has between 20-30 organizations formally committing as Partners. The main work groups include: Community

Programming (youth, adult education & health), Infrastructure / Public Spaces, Business Districts, and Housing. Additional work groups may focus on special projects like marketing and perception. A project management team oversees work groups, resident engagement opportunities, and neighborhood capacity building.

Staff from the City's Community Development Department is currently overseeing the project management team, and helping the work groups get up and running. This provides continuity in the transition from the planning phase to the implementation phase. Staff from other City departments may be requested to participate in work groups. Each work group will be responsible for creating an annual work plan and budget. Projects that require City funding or staff resources will either be approved on a departmental basis through incorporation into annual department work plans or, if necessary, come before Council for consideration. The term of the MOUs is two (2) years, however, it is anticipated that the Viva East Bank! initiative will be a minimum of five (5) years. After two (2) years, the City and other partners' roles will be reevaluated.
