AGENDA HEADING:

Approving the renewal of Websense Web Filter license from Insight Public Sector, 6820 South Harl Avenue, Tempe, AZ, 85283, for software used to filter Internet access by City employees.

SYNOPSIS:

Recommend approval of a three-year contract with Insight Public Sector for Websense Internet monitoring and filtering software. The City moved from an annual to a multi-year contract six (6) years ago to realize cost savings. The cost of the three-year contract is \$64,287, which reduces the cost per license and eliminates any annual price increases for the next three (3) years.

ADDITIONAL INFORMATION:

The City of Des Moines uses Websense software to filter Internet access by City employees. The purpose of the software is to limit access to specific web sites, content or applications. It provides a cost-effective and efficient method to allow City employees to use the online resources safely and productively by controlling Internet access, preventing inappropriate content from entering the network, and limiting bandwidth-intensive sites and applications. This software is also used to prevent the use of file sharing software to share copyrighted movies and music on the Internet access we provide to the public at the Des Moines Public Libraries and the Western Gateway Sculpture Park.
