AGENDA HEADING:

Acceptance of proposal from MidAmerican Energy Company (MidAmerican) for relocation of an overhead electric distribution line for the Southeast Connector Project in the amount of \$39,859.14.

SYNOPSIS:

Recommend approval of the proposal from MidAmerican for the relocation of an overhead electric distribution line for the Southeast Connector project in the amount of \$39,859.14, to accommodate construction of a bridge over the Norfolk Southern Railway Company at approximately S.E. 22^{nd} Street, north of Scott Avenue.


<u>Funding Source</u>: 2014-2015 Capital Improvement Program (CIP) – Page Street–31, Southeast

Connector – S.E. 14th Street to S.E. 30th Street, ST249, \$19,929.57 G.O. Bonds, and \$19,929.57 RISE

ADDITIONAL INFORMATION:

MidAmerican has a license agreement with Norfolk Southern Railway Company for operation and maintenance of an overhead electric line within railroad right-of way in the vicinity of S.E. 22nd Street and Scott Avenue. The Southeast Connector includes construction of a viaduct over the Norfolk Southern Railway that is in conflict with the existing MidAmerican overhead electric line. The relocated electric line will be placed below grade within Norfolk Southern Railway Company right-of-way and under the Southeast Connector viaduct. MidAmerican will be completing the work within Norfolk Southern Railway Company right-of-way.

MidAmerican has provided a proposal for relocation of the overhead electric line to underground for a cost of \$39,859.14, which includes costs for winter construction.
