## **AGENDA HEADING:**

Resolution authorizing support of a grant application by Community Housing Initiatives (CHI) for funding a proposed housing rehabilitation initiative in the East Bank neighborhoods.

#### **SYNOPSIS:**

The U.S. Conference of Mayors (USCM) and WellsFargo have partnered to offer the CommunityWins grant program to member cities, who can nominate nonprofit initiatives or programs that address neighborhood stabilization, economic development, or job creation. CHI, a statewide nonprofit based in Des Moines, is proposing an initiative to rehabilitate and resell blighted residential properties in the East Bank neighborhoods, which meets goals of three (3) Neighborhood Revitalization Plans. CHI's application to the CommunityWins program requires the support of the Mayor to be eligible.

#### ADDITIONAL INFORMATION:

The USCM and WellsFargo have partnered to offer the CommunityWins grant program to member cities, who can nominate nonprofit initiatives or programs that address neighborhood stabilization – projects designed to stimulate growth and stability while assisting in the removal of blight and the rebuilding of neighborhoods, economic development – projects designed to promote business development, or job creation – projects designed to aid in local job creation or assist in job training. Over the next three (3) years, \$3 million will be made available with six (6) awards given nationally per year. Award amounts are based on city size, with two (2) awards per size category. The top award for a city of Des Moines' size is \$150,000, and the second award is \$50,000. A nonprofit organization must apply, with the full support of the Mayor for the proposed initiative or program.

CHI is an Iowa nonprofit dedicated to creating vibrant neighborhoods and communities through housing and development work. CHI is a major partner in the Viva East Bank! coalition, a group of nearly 30 community organizations working together to implement the neighborhood plans for Capitol East, Capitol Park, and Martin Luther King Jr. Park. The City approved all three (3) of the neighborhood plans in 2014 and is also a participant in the Viva East Bank! coalition.

For the grant application to the CommunityWins program, CHI is proposing an initiative to rehabilitate and resell at least 15 homes in the East Bank neighborhoods. The proposed initiative is one (1) of many strategies to improve the housing stock and increase home values, complementing the efforts of Habitat, HOME Inc., Rebuilding Together, the City's Community Development Department, and other

partners. The funding provided by the grant would help cover any gap CHI has from rehabilitating the homes, as current market sale prices frequently do not cover the costs to acquire and renovate homes in this area. The initiative is modeled after a program CHI has implemented in Dubuque, IA's Washington Neighborhood, where it has been successful at prompting significant improvements to the neighborhood's home values and conditions. Over time, the gap decreases as higher comparable sales are established.

Any application to the CommunityWins program must have the full support of the Mayor to be eligible. The application is due March 16, 2015 and awards will be announced in June 2015 at the USCM Annual Meeting. All award dollars must be utilized within one (1) year of receipt.
