AGENDA HEADING:

Hold public hearings to institute proceedings for the issuance of general obligation bonds for the fiscal year (FY) 2016 capital budget in the Capital Improvements Program (CIP) and levying a tax for the debt service of said bonds in FY2015-16.

SYNOPSIS:

Hold 10 public hearings on the issuance of general obligation bonds to fund the FY2016 capital budget in the CIP. This is the first step in the process to finance the construction of capital projects totaling \$29,565,000. The hearings are being held in tandem with the approval of the budget so that the debt payments associated with these projects can be included in the FY2016 City budget.

FISCAL IMPACT:

Amount: \$29,565,000 project funds plus interest and \$510,000 issuance cost. FY2015-16 debt service payment is estimated at \$960,000 and the rate at \$3.93 per \$1,000 taxable valuation.

Funding Source: FY2016 operating budget, property tax debt service levy, D001 ND400500

ADDITIONAL INFORMATION:

A public hearing must be held prior to any borrowing by the City. This hearing is to consider borrowing for the FY2016 capital improvement budget that will be submitted for approval by Council on March 9, 2015. The final sizing of the bonds will occur in May with the bond sale planned for June. City staff reviewed projects that anticipated the availability of non-City funding to determine the certainty of those funds. Below is the current status of non-City funding related to the projects that will be funded in part with bond proceeds from this issuance:

- Multi-Use Trail Bridges \$425,000 bonds (\$1,000,000 Private uncommitted, \$500,000 state-committed);
- East 42nd Avenue and Hubbell Avenue Intersection Improvements \$250,000 bonds (\$900,000 state uncommitted);
- 42nd Avenue Streetscape \$500,000 bonds (\$470,000 Private committed, \$480,000 federal committed);
- Indianola Avenue Widening SE 14th Street to Army Post Road \$500,000 bonds (\$2,550,000 federal committed);
- Park Avenue Widening SW 56th Street to SW 63rd Street \$250,000 bonds (\$2,050,000 federal committed);

- S.E. Connector \$500,000 bonds (\$3,582,000 federal committed; approximately \$30 million of funding to complete project uncommitted);
- Traffic Control Neighborhood Program \$115,000 bonds (\$150,000 state committed);
- Traffic Signals, Channelization, and School Crossings \$525,000 bonds (\$480,000 federal committed; \$365,000 state committed);
- UPRR Crossing Closures Mitigation \$500,000 bonds (\$1,600,000 railroad committed);
- Walnut Street Streetscape \$2,200,000 bonds (\$1,400,000 private uncommitted); and
- Traffic Signal Interconnection \$140,000 bonds (\$658,000 federal committed).

Projects requiring non-City funding will be reviewed once again prior to issuing the debt in the spring.
