#### **AGENDA HEADING:**

Subdivision improvement bond release for Summersfield Plat 2.

## **SYNOPSIS:**

Recommend release of the original subdivision improvement bond in the amount of \$2,773 Summersfield Plat 2 subdivision, since the required improvements have been completed to the satisfaction of the Engineering Department.

## ADDITIONAL INFORMATION:

On December 4, 2006, the City Council approved and accepted the original bond for infrastructure improvements in the amount of \$2,773 for public sidewalk work in the Summersfield Plat 2 subdivision. The developer has requested a release of the required surety since all of the subdivision improvement work has now been satisfactorily completed.

Summersfield Plat 2 is located at 4605 Hubbell Avenue and consists of one 2.5 acre lot containing a 21-dwelling unit townhome project that had construction completed in 2012.
