AGENDA HEADING:

Approving \$6,000 amendment to existing blanket purchase order with IPS Group for monthly management services and transaction fees for credit card enabled meters.

SYNOPSIS:

Recommend approval of a \$6,000 amendment to an existing blanket purchase order with IPS Group for monthly management services and transaction fees on credit-card enabled meters, resulting in a total blanket purchase order of \$30,000.

ADDITIONAL INFORMATION:

On April 22, 2013, by Roll Call No. 13-0656, the City Council approved the purchase of credit card enabled Smart Meters from IPS Group that would provide alternative payment options for visitors and residents in the downtown area. The downtown area currently has approximately 4,000 parking meters. The Traffic and Transportation Division has an annual replacement program to upgrade the existing coin-operated parking meters to credit-card enabled meters. Currently, there are over 325 credit card enabled meters in the downtown area, with another 300 to be installed this summer. Each credit card enabled meter has a monthly software support fee of \$2.00, a Gateway Wireless fee of \$3.75 monthly, and an individual transaction fee of \$0.13 per transaction for each credit card purchase. The city recaptures some of these funds to cover the transaction fee by having credit-card enabled meters charge a minimum of one (1) hour or \$1.00 worth of time to cover the individual transaction fee.

The City has seen the usage of credit card enabled meters increase. With this increase in use of credit card enabled meters, comes a need to have an increase in the existing \$25,000 blanket purchase order with the IPS Group to account for the increased software support and transaction fees.
