AGENDA HEADING:

Hearing on Birdland Pump Station Repairs: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as C. L. Carroll Co., Inc. (Jon P. Rissman, President), \$655,222.

SYNOPSIS:

This is a public hearing to allow for public input on the Birdland Pump Station Repairs and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project provides the removal and replacement of a deteriorated sanitary pump, ventilation system, and the installation of a standby generator. The pump station was constructed in 1964 and one (1) of the pumps has been previously replaced. The original existing pump and electrical controls have deteriorated and need to be replaced.

ADDITIONAL INFORMATION:


On March 23, 2015, by Roll Call No. 15-0485, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Birdland Pump Station Repairs. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Birdland Pump Station Repairs, 07-2015-002. The improvement includes the repairs of the existing sanitary pump station including the removal and replacement of an existing pump, modifications to the ventilation system, modifications of the electrical and control system, installation of a standby generator, and miscellaneous items; all in accordance with the contract documents, including Plan File Nos. 567-185/194, located in the 1800 block of Saylor Road, Des Moines, Iowa.

Sealed bids for said improvement were submitted by the following bidders:

C. L. Carroll Co., Inc., Des Moines, IA Prostruct Construction, Inc., West Des Moines, IA Building Crafts, Inc., Wilder, KY The Waldinger Corporation, Des Moines, IA Baker Electric, Inc., Des Moines, IA

The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on April 7, 2015.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by C. L. Carroll Co., Inc. (Jon P. Rissman, President, 3623 6th Avenue, Des Moines, IA 50313) in the amount of \$655,222, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
