ADDITIONAL INFORMATION:

On January 12, 2015, by Roll Call No. 15-0002, and April 6, 2015, by Roll Call No. 15-0556, the Municipal Housing Governing Board approved selling the DMMHA's remaining scattered site single-family homes. The Governing Board's action was submitted to the U.S. Department of Housing and Urban Development's (HUD) Special Application Center; however, the DMMHA has not received HUD's formal approval in order to close on said sales.

The purchasers of these scattered site single-family homes would like to gain access to begin renovations to their respective properties. The DMMHA is supportive of this action as the DMMHA was verbally informed that the DMMHA's requests have been approved; however, DMMHA hasn't received the official written approval. Allowing the purchasers to gain access to these units will enable renovations to begin this spring/summer during the construction season while also allowing the DMMHA to remove these units from DMMHA's mowing contractor's list of properties to maintain; thereby, saving DMMHA money and time.

The License Agreements and Release and Waiver of Liability have been prepared by the City's Legal Department and the Housing Services Director is requesting approval to execute the license agreements with the interested parties that were awarded the seal bid sales.
