AGENDA HEADING:

Hearing on Fire Station No. 7 Reroofing: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Academy Roofing & Sheet Metal of the Midwest, Inc. dba Academy Roofing & Sheet Metal Co., Brian Krumm, President, \$88,400.

SYNOPSIS:

This is a public hearing to allow for public input on the Fire Station No. 7 Reroofing and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the installation of a single-ply thermoset roofing system over new insulation after the complete removal of the existing roofing. The fire station was built in the mid-1970s. The original built-up roofing was covered by a single-ply membrane in 1998. The existing roofing system has deteriorated over time resulting in leaks throughout the building.

ADDITIONAL INFORMATION:

On April 6, 2015, under Roll Call No. 15-0564, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Fire Station No. 7 Reroofing. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Fire Station No. 7 Reroofing, 10-2015-003. The improvement includes the complete removal of the existing roofing materials and installation of a single-ply thermoset roofing system over new insulation, removal and reinstallation of the sheet metal flashings and copings, and asbestos abatement of the roofing, flashing, and base sheets; all work in accordance with the contract documents including Plan File Nos. 568-169/171, located at Fire Station No. 7, 3500 E. 12th Street, Des Moines, Iowa.


Sealed bids for said improvement were submitted by the following bidders:
