# **AGENDA HEADING:**

Hearing on Fire Stations No. 2, 5, 7, and 9 Bathroom Remodeling: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Bryan Crow Construction, Inc., Jerry Crow, President, \$285,217.

#### SYNOPSIS:

This is a public hearing to allow for public input on the Fire Stations No. 2, 5, 7, and 9 Bathroom Remodeling and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project provides for the renovation and upgrades to the bathrooms and showers at Fire Stations No. 2, 5, 7, and 9. These fire stations were constructed in 1973 and 1974, and are now deteriorated and in need of repair. The proposed improvements will update the finishes, plumbing, and lighting. The improvements at Fire Station No. 7 and 9 address items identified in the Fire Station Study, which were identified as needing immediate attention. These items include repairing water leaks, tile issues, and corrosion issues in the bathroom facilities.


On April 20, 2015, under Roll Call No. 15-0643, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Fire Stations No. 2, 5, 7, and 9 Bathroom Remodeling. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Fire Stations No. 2, 5, 7, and 9 Bathroom Remodeling, 10-2015-004. The improvement includes renovation of bathrooms in four (4) fire stations, including but not limited to removal and replacement of wall and floor tile, shower bases, shower ceilings, toilet accessories, toilet partitions, plumbing fixtures, and light fixtures; all in accordance with the contract documents including Plan File No. 567-195/198, located at Fire Station No. 2, 1727 E. Walnut Street; Fire Station Number 5, 711 42<sup>nd</sup> Street; Fire Station No. 7, 3500 E. 12<sup>th</sup> Street; and Fire Station No. 9, 4800 Douglas Avenue, Des Moines, IA.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Bryan Crow Construction, Inc., Jerry Crow, President, 14407 University Avenue, Waukee, IA, 50263 in the amount of \$285,217, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
