AGENDA HEADING:

Hold hearing for conveyance of City-owned property adjoining 5908 Chamberlain Drive to Andrew and Claudia Lorentzen for \$200.

SYNOPSIS:

Recommend approval of conveyance of City-owned property located east of and adjacent to 5908 Chamberlain Drive to Andrew P. and Claudia P. Lorentzen, 5908 Chamberlain Drive, Des Moines, Iowa, 50312, for \$200. This action is required by Iowa law prior to making a final determination on the proposed sale by resolution. The sale of the City's property will allow the buyers to assemble the land with their existing residential lot. There is no current or anticipated public need for this property, and this conveyance will eliminate future maintenance and liability costs for the City and will return the property to the tax rolls.



ADDITIONAL INFORMATION:

On January 29, 1968, by Roll Call No. 68-325, the City of Des Moines approved Ordinance No. 7596 vacating the right-of-way located east of and adjacent to 5908 Chamberlain Drive, but the vacated right-of-way was not conveyed at that time. There is no current or anticipated public need for this property, and this conveyance will eliminate future maintenance and liability costs for the City and will return the property to the tax rolls.

Andrew P. and Claudia P. Lorentzen own the property at 5908 Chamberlain Drive, which is located west of and adjoining the City's property. The Lorentzens have offered to the City of Des Moines the purchase price of \$200 for the purchase of the property. The adjoining owner on the east side of the property at 5830 Chamberlain Drive was also offered the opportunity to purchase half of the property, but they notified the City that they were not interested in purchasing any of the property. The property to be conveyed consists of approximately 1,600-square-feet and the purchase price reflects the fair market value of the property, as currently estimated by the City's Real Estate Division.
