**AGENDA HEADING:**

Third addendum to Boundary Roads Maintenance Agreement with Warren County, amending the list of roads due to the 2011 annexation of property in northern Warren County.

**SYNOPSIS:**

Recommend approval of the third addendum prepared to modify the agreement between the City of Des Moines and Warren County for maintenance of boundary roads following the 2011 annexation. The addendum reflects changes in both quantity of roads to be maintained and assigned responsibilities for maintenance.

**FISCAL IMPACT:**

Amount: The City’s share of the maintenance responsibilities for the roads will be funded in the Public Works Department’s Operating Budget.

Funding Source: Fiscal Year (FY) 2015-16 Public Works Department Operating Budget, PW240402, Street Maintenance Fund, Page 238

**ADDITIONAL INFORMATION:**

The City of Des Moines entered into a boundary roads maintenance agreement with Warren County on November 7, 1993, to divide the maintenance responsibilities for various roads which constitute the boundary line between the City and County. The first addendum to this agreement, entered into on December 18, 1995, amended the list of roads subject to the agreement. The second addendum to this agreement, entered into on July 10, 2002 amended the list of roads subject to the agreement. This proposed third addendum again amends the list of roads subject to the agreement due to the 2011 annexation of property in northern Warren County.
