AGENDA HEADING:

Hold public hearings regarding the issuance of not to exceed \$36,550,000 General Obligation Bonds for refunding and refinancing certain outstanding debt and take action for the issuance.

SYNOPSIS:

Hold public hearing regarding the issuance of not to exceed \$36,550,000 General Obligation Bonds to pay the cost of refunding and refinancing General Obligation Bonds, Series 2005E, General Obligation Refunding Bonds, Taxable Series 2007A, General Obligation Bonds, Series 2008D, and General Obligation Bonds, Series 2008E (Urban Renewal), and institute proceedings for the issuance. The purpose of the refinancing is to achieve interest savings by refunding and refinancing debt with lower interest rates.

FISCAL IMPACT:

<u>Amount</u>: Not to exceed \$36,550,000.

<u>Funding Source</u>: Fiscal Year (FY) 2016 Operating Budget, Finance Department, Debt Service Fund, page 94.

ADDITIONAL INFORMATION:

A public hearing must be held prior to any borrowing by the City. After input is received, if Council decides to issue the bonds, action must be taken on a second roll call to institute proceedings for the issuance of not to exceed \$36,550,000 General Obligation Bonds to pay the cost of refunding and refinancing. The next step will be to direct the date of sale and approve a preliminary Official Statement describing the issuance. At the same time, new bonds will also be issued to fund certain projects in FY2016 through 2020 Capital Improvement Program. Council has already held the public meeting regarding bond issuance on March 9, 2015.
