#### **AGENDA HEADING:**

Approving Amendment No. 4 to Operating Contract between the City of Des Moines and the Des Moines Metropolitan Wastewater Reclamation Authority (WRA).

## **SYNOPSIS:**

Recommend approval of Amendment No. 4 to the Operating Contract between the City of Des Moines and the WRA to reflect the changes needed for participation in Iowa Communities Risk Pool (ICAP) for property coverage and changes to allow use of equipment, personal property and vehicles by the Operating Contractor for its municipal operations.

FISCAL IMPACT: NONE

#### ADDITIONAL INFORMATION:

The WRA Insurance Subcommittee has recommended that the WRA participate in ICAP for property risks versus purchased property insurance which is required under the Operating Agreement. For this reason, an amendment to the Operating Contract between the WRA and the City of Des Moines is necessary. The amendment reflects changes needed for participation in ICAP for property coverage, and also includes changes to allow use of equipment, personal property, and vehicles by the Operating Contractor for municipal operations while indemnifying the WRA.
