# **AGENDA HEADING:**

Approving an amendment to the schedule of fees regarding the administrative penalties for false fire alarms under Chapter 38 of the Municipal Code.

#### SYNOPSIS:

Approving an amendment to the schedule of fees regarding the administrative penalties for false fire alarms under Chapter 38 of the Municipal Code. This amendment occurs in conjunction with a revised notification to the building owner providing potential remedies for correcting the issue causing the false alarm, and increases efficiency of staff resources, by facilitating the automation of the false alarm billing process; thereby, reducing staff hours devoted to the process.

#### FISCAL IMPACT:

<u>Amount</u>: Approximately \$15,000 revenue increase annually.

Funding Source: Fiscal Year (FY) 2016 Operating Budget, G001, FD104113, page105

## **ADDITIONAL INFORMATION:**

Approval of this ordinance amends the current Fire Department Fire Prevention Bureau fee structure for false fire alarms. This amendment would increase the first offense false fire alarm fee from \$100 to \$150 and would maintain all subsequent false fire alarm fees at \$150. Presently, staff time is devoted to determining whether each false alarm is a first or subsequent offense to determine the appropriate fee. Amending the fees to be the same regardless of the number of offenses will conserve staff time needed to complete this task. To provide sufficient time to incorporate the new fee structure into the automated billing process, it is proposed that this revised fee structure will be effective beginning on September 1, 2015.
