AGENDA HEADING:

Approving the purchase of replacement vehicles for various City Departments.

SYNOPSIS:

Recommend approval of the purchase of seven (7) vehicles for the City fleet in accordance with specifications of Bid No. V15-120 to the low responsive bidders as follows:

- Bob Brown Chevrolet, 3600 111th Street Urbandale, Iowa 50322 (Ron Brown, Owner) in the amount of \$27,988.00 for low responsive bid;
- Charles Gabus Ford, 4545 Merle Hay Road, Des Moines, Iowa 50310 (Gene Gabus, President) in the amount of \$109,746.00 for low responsive bids;
- Stivers Ford, 1450 E. Hickman Road, Waukee, Iowa 50263 (Scott Politte, General Manager) in the amount of \$31,348.00 for the low responsive bid; and
- Stew Hanson Dodge City, 12103 Hickman Road, Des Moines, IA 50323, (Dan Boetcher, General Manager) in the amount of \$29,945.00 for low responsive bid.

Bids were solicited to replace vehicles in the City fleet that meet or exceed established replacement criteria and approved for replacement by the Fleet Oversight Committee. Recommendations for award are for the low compliant bidder for each item. The lowest bidder for item 2, Bob Brown Chevrolet is not compliant in the required engine size. The lowest bidder for item 5, Bob Brown Chevrolet is not compliant with the required 72 inch interior roof height.
