AGENDA HEADING:

Authorization to proceed with acquisition of the necessary right-of-way and easements for the East 46th Street and Hubbell Avenue Intersection Improvements Project by gift, negotiation, or eminent domain.

SYNOPSIS:

Recommend approval of authorization to proceed with acquisition of the necessary right-of-way and easements for the East 46th Street and Hubbell Avenue Intersection Improvements Project by gift, negotiation, or eminent domain. This action is required by Iowa law before the City can initiate the right-of-way acquisition process under eminent domain. This project provides for the installation of a new traffic signal at the intersection of East 46th Street and Hubbell Avenue, along with widening for left turn lanes on Hubbell Avenue and right turn lanes on East 46th Street.

FISCAL IMPACT:

Amount: \$60,000 total estimated right-of-way acquisition and closing costs.

<u>Funding Source</u>: 2015-16 CIP, Page Street Improvements – 12, East 46th and Hubbell Avenue Intersection Improvements, ST254.

ADDITIONAL INFORMATION:


On May 19, 2014, by Roll Call No. 14-0743, the City Council approved execution of Iowa Department of Transportation (IDOT) Agreements No. 2015-TS-002 and No. S-2014-0444 for East 46th Street and Hubbell Avenue Intersection Improvements.

Hubbell Avenue (U.S. 6) at East 46th Street is currently a four-lane, undivided roadway. East 46th Street north and south of Hubbell Avenue is a two-lane roadway constructed as a rural cross-section. The improvement consists of widening Hubbell Avenue approaches in order to provide left turn lanes on East 46th Street. A northbound right turn lane will be constructed on East 46th Street approaching Hubbell Avenue. Pedestrian crossings will be provided on all legs of the intersection. The existing sidewalk will be extended south along the east side of East 46th Street to Delaware Elementary School, and on the north side of Hubbell Avenue from East 46th Street to the existing sidewalk. New traffic signals will be installed, including Hubbell Avenue left-turn phasing. The signals will be interconnected to the existing traffic signals at Hubbell Avenue and Broadway Avenue.

At this time, approximately 11 partial fee acquisitions (PA), nine (9) temporary construction easements (TE) and one (1) permanent storm sewer and surface water flowage easement (PE) from 14 property owners will be required for this project. Relocation assistance will not be required.
