AGENDA HEADING:

Approval of United Way of Central Iowa's (UWCI) Funding Investment Agreement for Family Self-Sufficiency Program.

SYNOPSIS:

Approval to execute the UWCI Community Investment Agreement to secure grant funding to aid in increasing case management services to Family Self-Sufficiency participants.

ADDITIONAL INFORMATION:

The UWCI provides funding for the Housing Services Department's Des Moines Municipal Housing Agency's (DMMHA) Family Self-Sufficiency Program. The funds from this grant support the Family Self-Sufficiency's case management services to Family Self Sufficiency participants in achieving economic self-sufficiency.

The Family Self-Sufficiency program provides case management services to participating Public Housing and Section 8 participants. Individual development plans are created to aid participants in reaching their educational, employment, and personal goals. The Agency's Family Self-Sufficiency Coordinators are funded through specialized grants from the U.S. Department of Housing and Urban Development. The UWCI grant funds enable the DMMHA to increase the number of families being served through this program.

The DMMHA has received a 2015-2016 Investment Agreement of \$25,000 for July 1, 2015 to December 31, 2015 for the first half fiscal year 2015-2016. Last year, the UWCI implemented a new funding model in which the Investment Agreement between UWCI and DMMHA was designed as a 1-year contract while defining the intent to fund for three (3) years.

Due to the timeline requests of UWCI in returning the Investment Agreement, the Housing Services Department is also seeking authorization for the City Manager or his designee to sign the Investment Agreement upon review and approval by the City's Legal Department.
