AGENDA HEADING:

Hearing on 2015-2016 Expanded Street Resurfacing Program - Contract 1. Resolution approving plans, specifications, form of contract documents, engineer’s estimate, receive and file bids, and designating lowest responsible bidder as Grimes Asphalt and Paving Corporation, Kurt Rasmussen, President, \$1,524,496.60.

SYNOPSIS:

This is a public hearing to allow for public input on the 2015-2016 Expanded Street Resurfacing Program - Contract 1 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for full depth patching, scarification of existing asphalt streets, and hot mix asphalt (HMA) overlay of arterial and residential streets Citywide. The project addresses citizen concerns regarding the condition of City streets by preserving deteriorating infrastructure.

FISCAL IMPACT:

Amount: \$1,524,496.60 Construction Contract (\$1,610,000 City Engineer's Estimate)

Funding Source: 2015-2016 CIP, Page Street - 39, Special City-wide Street Improvements, ST217, Being: \$1,264,422.65 in Gaming Monies; with the remaining \$260,073.95 for resurfacing of Greenwood Park road and parking lot being transferred from Page Parks - 13, Road, Sidewalk, and Utility Improvements - Parks, PK175, G.O Bonds.

ADDITIONAL INFORMATION:

On July 13, 2015, under Roll Call No. 15-1120, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2015-2016 Expanded Street Resurfacing Program - Contract 1. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2015-2016 Expanded Street Resurfacing Program - Contract 1, 06-2015-006. The improvement includes scarification of existing asphalt streets, furnish and place Hot Mix Asphalt (HMA), furnish and place pavement markings, and other incidental items; in accordance with the contract documents, including Plan File Nos. 569-111/133, at the following locations in the City of Des Moines, Iowa:

- Greenwood Park road and parking lot;
- 59th Street - Boston Avenue to Douglas Avenue;
- 49th Street - Urbandale Avenue to Douglas Avenue;
- North Waterbury Road - Waterbury Circle to 56th Street;
- E. Hull Avenue – Delaware Avenue to E. 24th Street;
- E. Watrous Avenue - S.E. 5th Street to S.E. 14th Street;
- Porter Avenue - S.W. 9th Street to South Union Street; and
- Army Post Road - S.E. 5th Street to S.E. 14th Street.

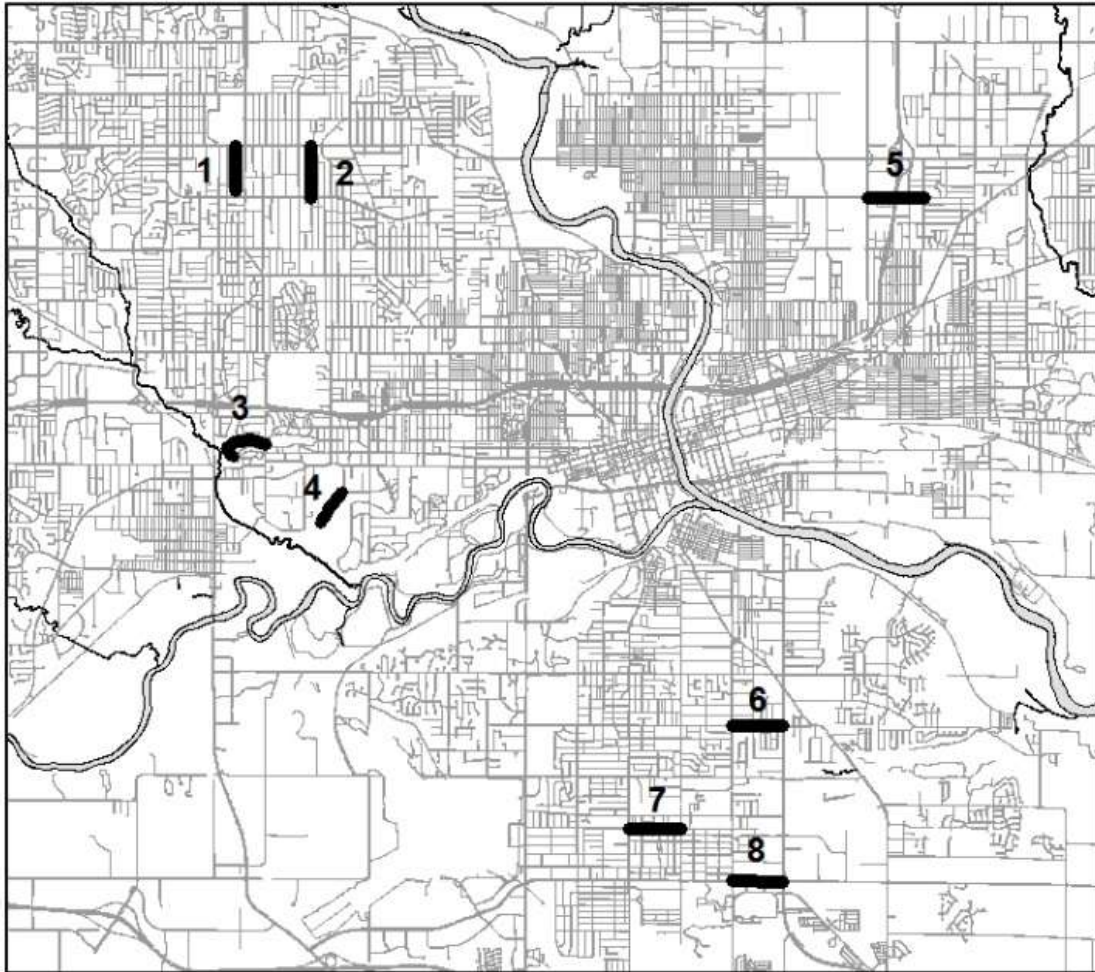

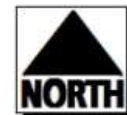
