AGENDA HEADING:

Hearing on Fire Station No. 2 Reroofing. Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as West Central Roofing & Guttering, Inc., Harley R. Leaders, President, \$89,250.

SYNOPSIS:

This is a public hearing to allow for public input on the Fire Station No. 2 Reroofing and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the installation of a single-ply thermoset roofing system over new insulation after the complete removal of the existing roofing. The fire station was built in the mid-1970s. The original built-up roofing was replaced in 1997. The existing roofing system is out of warranty and has deteriorated over time resulting in leaks.


On July 13, 2015, under Roll Call No. 15-1118, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Fire Station No. 2 Reroofing. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Fire Station No. 2 Reroofing, 10-2015-007. The improvement includes the complete removal of the existing roofing materials and installation of a single-ply thermoset roofing system over new insulation, and replacement of the sheet metal copings; all work in accordance with the contract documents including Plan File Nos. 569-106/108, located at Fire Station No. 2, 1727 E. Walnut Street, Des Moines, Iowa.

Sealed bids for said improvement were submitted by the following bidders:

The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on July 28, 2015.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by West Central Roofing & Guttering, Inc., Harley R. Leaders, President, 201 340th Street, Minden, IA, 51553 in the amount of \$89,250, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
