### **AGENDA HEADING:**

Approving and authorizing the execution of Iowa Department of Transportation (IDOT) Agreement for the East 42nd Street and Hubbell Avenue Intersection Widening and Signalization Project.

# **SYNOPSIS:**

Recommend approval of IDOT Agreement No. 2016-TS-005 Traffic Safety Improvement Program funds for the East 42nd Street and Hubbell Avenue Intersection Widening and Signalization Project. This project includes installing traffic signals, widening the Hubbell Avenue approaches to the intersection, adding left turn lanes, and adding a northbound right turn lane on East 42nd Street.

### **FISCAL IMPACT:**


Amount: \$2,400,000

## Funding Source:

- \$500,000 IDOT Traffic Safety Improvement Funds
- \$1,900,000 2015-2016 Capital Improvement Program (CIP), Page Street-11, East 42nd Street and Hubbell Avenue Intersection Improvements, ST257, G.O. Bonds

## **ADDITIONAL INFORMATION:**

This \$2.4 million project includes installing traffic signals, widening the Hubbell Avenue approaches to the intersection, adding left turn lanes, and adding a northbound right turn lane on East 42nd Street. From 2009 through 2013, left turn and right angle collisions accounted for over half of the collisions at this intersection. Installing traffic signals and adding left turn lanes can reduce the number of left turn collisions and right angle collisions. Pedestrian traffic crossing Hubbell Avenue will be safer after these improvements are completed.
