AGENDA HEADING:

Approving Change Order No. 2 with Grimes Asphalt and Paving Corporation for additional work on the Cownie Baseball Facility Parking Lot, in an amount not to exceed \$39,755.

SYNOPSIS:

Recommend approval of Change Order No. 2 in an amount not to exceed \$39,755 with Grimes Asphalt and Paving Corporation, Kurt Rasmussen, President, P.O. Box 3374, Des Moines, IA, 50316 to install new subdrain, construct an area intake, and grade adjacent to the east parking lot at the Cownie Baseball Facility.

FISCAL IMPACT:

Amount: \$39,755

ADDITIONAL INFORMATION:

On March 9, 2015, under Roll Call No. 15-0453, the City Council awarded a construction contract in the amount of \$779,235.25 to Grimes Asphalt and Paving Corporation for the Cownie Baseball Facility Parking Lot. The contractor began work on this project on April 14, 2015.

Drainage issues were identified between the toe of the existing slope and the outfield fences. This drainage improvement has been identified as a future project with the Community Foundation of Greater Des Moines. The work included in this change order provides the opportunity to construct this additional long-term drainage improvements at the facility. Constructing these improvements now will eliminate the need to reconstruct sidewalks and infrastructure that would be affected by these improvements if they were constructed in the future. This change order includes installation of 1,211-linear-feet of new 6-inches subdrain, construction of a new area intake, and connections to existing subdrain lines to improve drainage behind the outfield fences of the two (2) south ball fields. This change order also includes grading along the east parking lot sign to reduce erosion and provide a safer slope to mow and maintain grass.
