AGENDA HEADING:

The U.S. Department of Homeland Security allocates funds to states and local governments through the federal Homeland Security Grant Program for approved initiatives supporting national priorities and state strategies directed toward prevention, response, mitigation and recovery efforts related to terrorist attacks.

The IHSEMD has awarded the City a grant of up to \$500,000 and has prepared a 2015 Homeland Security Grant Program Commitment to Award and Accept Funds agreement between IHSEMD and the City to perform work supporting Cyber Risk Reduction (Grant #HSGP-15-SHSP-1103), 2015 Grant Agreement.
