AGENDA HEADING:

Approving execution of Fiscal Year (FY) 2015 Cooperative Agreement between the City of Des Moines Civil and Human Rights Commission and the United States Department of Housing and Urban Development (HUD).

SYNOPSIS:

This is an annual agreement between HUD and the City of Des Moines Human Rights Commission. Staff recommends Council approval of the FY2015 Cooperative Agreement.

FISCAL IMPACT:

Amount: \$76,275.00 (Revenue)

Funding Source: Human Rights-Services, FY2015-16 Operating Budget, page 42.

ADDITIONAL INFORMATION:

This is an annual agreement between HUD and the City of Des Moines Civil & Human Rights Commission. This year's allocation of \$76,275 includes \$47,400 for complaint processing, \$17,875 for HUD approved training, and \$11,000 for administrative costs.

The allocation varies year to year based on the number of Fair Housing complaints that the Department dual files with HUD. During the last fiscal year, the Department dual filed 19 housing complaints with HUD.

The administrative cost and training allocations were increased for all agencies by HUD in March of 2015. Administrative costs increased from \$6,000 to \$11,000 based on the number of cases cross filed during the last fiscal year. Training increased from \$16,250 in FY14 to \$17,875 in FY15 based on population size for Des Moines. These funds are to be used for mandatory and HUD approved trainings.
