AGENDA HEADING:

Resolution approving first amendment to Urban Renewal Development Agreement with Doll Distributing, LLC for conveyance and redevelopment of City-owned property in the Guthrie Avenue Business Park Urban Renewal Area.

SYNOPSIS:

On September 28, 2015, by Roll Call No. 15-1646, City Council approved terms of agreement with Doll Distributing, LLC (Mark Doll, CEO, 815 South Branch Waukee, Iowa 50263) for the purchase of City-owned land in the Guthrie Avenue Business Park Urban Renewal Area. The property is located south of Thompson Avenue to E. Jefferson Avenue on De Wolf Street and will assist the company with a planned expansion project.

This amendment provides for clarification regarding the soil stockpile that is currently located on the property. It will allow for the company to relocate a soil stockpile adjacent to City-owned land, rather than removing it to another site.

FISCAL IMPACT:

Amount: The Company will purchase City-owned land at fair market value for an estimated \$66,908.70, which is based upon fair market value of \$1.35 per square foot by 49,562-square-feet. A Good Faith Deposit was provided in the amount of \$6,690.87 with the submission of the Urban Renewal Development Agreement. At the time of closing, the developer will receive credit for the Good Faith Deposit, credit for the lowest of three (3) bids received for survey of the property, and credit for moving the soil stockpile currently located on the property.

Funding Source: In accordance with City policy, land sales proceeds from Doll Distributing, LLC to be re-deposited in the Guthrie Avenue Urban Renewal Area.

ADDITIONAL INFORMATION:

Doll Distributing employs 200 people in the City of Des Moines and approximately 300 people in total. The Guthrie Avenue Business Park site at 1901 De Wolf Street serves as the company’s corporate headquarters. The purchase of land will provide additional ability for the company to enhance their truck circulation and loading/unloading activities.

The total estimated cost of site preparation and development for the currently proposed project is \$500,000. The land will be sold for an estimated \$66,908.70, with a Good Faith Deposit in the amount

of \$6,690.87 provided with the submission of the Urban Renewal Development Agreement. At the time of closing, the developer will receive credit for the Good Faith Deposit, credit for the lowest of three (3) bids received for survey of the property, and credit for moving the soil stockpile currently located on the property. Construction is proposed to begin in fall 2015 and will be completed by December 30, 2015.
