### **AGENDA HEADING:**

Approving Supplemental Agreement No. 3 to the Professional Services Agreement with Genus Landscape Architects, P.C. for extended administrative and construction phase services for Beaver Avenue Streetscape – Beavercrest Drive to Fagen Drive, not to exceed \$24,800.

#### **SYNOPSIS:**

Recommend approval of Supplemental Agreement No. 3 to the Professional Services Agreement with Genus Landscape Architects, P.C., Brett Douglas, President, 325 East 5<sup>th</sup> Street, Des Moines, Iowa, 50309, not to exceed \$24,800, for extended administrative and construction phase services for Beaver Avenue Streetscape – Beavercrest Drive to Fagen Drive.

#### **ADDITIONAL INFORMATION:**

On August 27, 2012, by Roll Call No. 12-1387, City Council approved a professional services agreement with Genus Landscape Architects, P.C. for evaluation, design, and construction phase services for the Beaver Avenue Streetscape – Beavercrest Drive to Fagen Drive project. This project includes enhancement of the Beaver Avenue and Urbandale Avenue intersection to improve vehicular and pedestrian safety, new traffic signalization, drainage improvements with the installation of storm sewer pipe, site furnishings, landscaping with plantings, sidewalks, driveways, and HMA pavement overlay.

On April 6, 2015, by Roll Call No. 15-0567, City Council approved Supplemental Agreement No. 2 for additional construction administration and inspection services for the Beaver Avenue Streetscape – Beavercrest Drive to Fagen Drive project. This supplemental agreement was necessary due to utility conflicts and unanticipated sewer conflicts that caused construction delays; thus increasing the duration of the project through August 2015.

During the 2015 construction season, the project experienced an additional four (4) weeks of construction delays due to lighting and power distribution pole installation and corresponding power service hookups to properties. This work delayed the full opening of the corridor until September 2015. Staff recommends approval of Supplemental Agreement No. 3 for extended administrative and construction phase services with Genus Landscape Architects, P.C.
