SYNOPSIS:

The Pioneer Columbus Community Center has been serving programming and activity needs of adults, youth, and senior citizens for over 40 years. The proposed improvements will provide for a new north side public entrance, check-in desk and fitness space, upgrade finishes in the existing weight training room, and enlarge the primary conference room in order to allow the Center to better meet current and future programming needs.

ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Pioneer Columbus Community Center Remodeling, 10-2014-002. The improvement includes a partial renovation of interior spaces at the Pioneer Columbus Community Center including limited foundation excavation, concrete foundations, concrete flat work, metal window and door assemblies, millwork, interior floor, wall and ceiling finishes, painting and related mechanical, plumbing, fire protection and electrical systems; all in accordance with the contract documents including Plan File Nos. 561-157/189, located at the Pioneer Columbus Community Center, 2100 S.E. 5th Street, Des Moines, Iowa.
