

ADDITIONAL INFORMATION:

At its meeting on November 5, 2015, the City Plan and Zoning Commission voted to approve a request from Gary L. Randa to vacate a segment of Southwest 31st Street and Wolcott Avenue adjoining 3029 Wolcott Avenue in order to mitigate an existing fence encroachment, subject to reservation of any necessary easements for existing utilities.

Gary L. Randa, owner of 3029 Wolcott Avenue, has offered to purchase the vacated segment of Southwest 31st Street and Wolcott Avenue for \$150. The property to be conveyed consists of approximately 800-square-feet, and the purchase price of \$150 is equal to the estimated fair market value of the property as determined by the City's Real Estate Division. There is no current or anticipated public need for this property, and the City's conveyance of this property will allow the buyer to keep his fence in place.
