# AGENDA HEADING:

Hearing on Pioneer Columbus Community Center Remodeling. Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Rochon Corporation of Iowa, Inc., Ron Rochon, President, \$453,150.

#### SYNOPSIS:

This is a public hearing to allow for public input on the Pioneer Columbus Community Center Remodeling and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The Pioneer Columbus Community Center has been serving programming and activity needs of adults, youth and senior citizens for over 40 years. The proposed improvements will provide for a new north side public entrance, check-in desk and fitness space, upgrade finishes in the existing weight training room and enlarge the primary conference room in order to allow the center to better meet current and future programming needs.

## **ADDITIONAL INFORMATION:**

On November 23, 2015, under Roll Call No. 15-0278, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Pioneer Columbus Community Center Remodeling. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Pioneer Columbus Community Center Remodeling, 10-2014-002. The improvement includes a partial renovation of interior spaces at the Pioneer Columbus Community Center including limited foundation excavation, concrete foundations, concrete flat work, metal window and door assemblies, millwork, interior floor, wall and ceiling finishes, painting and related mechanical, plumbing, fire protection and electrical systems; all in accordance with the contract documents including Plan File Nos. 561-157/189, located at the Pioneer Columbus Community Center, 2100 S.E. 5<sup>th</sup> Street, Des Moines, Iowa.

The Finance Director has determined that funds are available for said improvement as stated above.
