Approval of purchase of Hewlett-Packard DL380 Gen 9 Server per Western States Contracting Alliance (WSCA) pricing agreement.

SYNOPSIS:

Recommend approval of the purchase of HP DL380 Gen 9 server from Hewlett-Packard Company, (8000 Foothills Boulevard, MS 5509, Roseville, California, 95747, Meg Whitman, President) per WSCA pricing agreement for equipment which is competitively bid. This server is to be used to expand the City’s VMware host cluster from three (3) to four (4) servers to allow for more virtual servers to be added.

ADDITIONAL INFORMATION:

VMhost servers are part of a cluster of physical servers that can run many virtual servers. Additional capacity is needed due to the growth of the number of virtual servers. These servers provide both day to day processing and backup for the current server clusters. The addition of another server to the cluster will provide more capacity and backup in case of failure of an individual server.
