#### **AGENDA HEADING:**

Resolution approving an Operational Agreement with Childtime Childcare, Inc. to operate and manage a childcare center in the Intermodal Transportation Facility at 6th Avenue and Center Street.

# **SYNOPSIS:**

Recommend approval of the operational agreement with Childtime Childcare, Inc. (David Baratta, SVP of Real Estate, Facilities and Market Development Strategy, 21333 Haggerty Road, Suite 300, Novi, Michigan, 48375) to continue to serve as operator of the childcare center in the Intermodal Transportation Facility at 6th Avenue and Center Street. The Operational Agreement is in the vital and best interests of the City and in accord with federal requirements associated with the Intermodal Transportation Facility. The Operational Agreement is for a 3-year term, plus a 3-year renewal option, with first-year's rent at \$3,005 per month, and annual rent increases thereafter based on increases in the Consumer Price Index, not to exceed 5% annually.

#### **FISCAL IMPACT:**

Amount: \$36,060 (first year revenue).


#### ADDITIONAL INFORMATION:

On April 28, 1997, by Roll Call No. 97-1549, the City Council entered into a 28E Agreement with the Des Moines Metropolitan Transit Authority (now Des Moines Area Regional Transit Authority) for construction and operation of a Park & Ride Facility. This facility included designs for a childcare facility to serve the needs of those families working in the downtown area.

Childtime Childcare, Inc. was selected as the childcare provider for this facility. On December 21, 1998, by Roll Call No. 98-3949, the City Council approved a 4-year lease agreement with an additional 2-year renewable option with Childtime Childcare, Inc.

On January 7, 2008, by Roll Call No. 08-076, the City Council approved an Operational Agreement with Childtime Childcare, Inc. to operate and manage the childcare facility until March 31, 2009 with an option to renew the Agreement for an additional five (5) years until March 31, 2014, which option to renew was exercised. The term of the 2008 Agreement expired on March 31, 2014 and has been continuing on a month-to-month basis under the same terms and conditions then in effect.

The City of Des Moines and Childtime Childcare, Inc. have negotiated a new Operational Agreement that includes, among other terms, a 3-year initial term, plus a 3-year renewal option, with an initial monthly rent of \$3,005. Annual rent shall be adjusted upward based on the percent increase in the Consumer Price Index for the previous 12 months, not to exceed 5% percent.
